- **A Genturi exhaust diverter or like device to divert the generator exhaust up and away from fellow RV'ers is required. No up-pipe, no space, no exceptions!**
- All RV's are to be "BACKED IN" to the assigned space. Your space will have an orange cone with your last name on a sign.
- Illegally parked vehicles will be towed at owner's expense and risk.
- Exercise pens only allowed on the blacktop within your designated space. ABSOLUTELY NO EX PENS ON THE GRASS. Green space is limited and must be available for all exhibitors. If ex pens are found set up on grass, they will be removed.
- You are responsible for clean conditions in and around your assigned space.
- All parking is at your own risk. The AWC assumes no responsibility for fire, theft and/or damage to any vehicle or its cargo.
- All units must be self contained. Dry camping only.
- No dumping of ANY kind. If you have leaky plumbing, repair before you travel.

You MUST have proof of Rabies vaccines for your dogs. They will waive the 2 dog limit for us. Aggressive dogs (Pit Bulls) not allowed. Ex-pens are not allowed at campsites.

When all applications are received, as it gets closer to the show, a site map will be sent to each applicant showing their assigned parking spaces. RV's will be parked according to length. You will also be given the proper entrance to be used for RV'ers which is NOT the main entrance off of Shawan Rd into the hotel parking lot. The parking lot has many tight turns so pay attention to the signs.
